## Carver Nebbe Honored



**Dr. Carver Nebbe**, psychiatrist and staff physician at Student Health, was recently welcomed as a **Distinguished Fellow of the American Psychiatric Association**. He joins an elite group of psychiatrists and this honor represents the significant contributions he has made to the field of psychiatry.

"Dr. Nebbe is dual board certified in psychiatry and family medicine," said Student Health Director Erin Baldwin. "He is a major asset to Student Health and the university as a whole."

The **Iowa Psychiatric Society** nominates people who have been a member for eight years. In order to be named a Distinguished Fellow, one must meet a challenging criteria. Criteria is given based on **academic achievement, occupational achievement, community involvement, and volunteer work**.
